Guidelines for the Authors:

- The length of a paper should be to 5 pages (in Ukrainian or English).
Text format – Microsoft Word. Times New Roman, 14 pt. Page format A4 (210x297 mm). Margins – 20 mm.
Line spacing – 1,5. Style – Normal.
- Information about author/s (alignment right):
 - surname, initials – bold;
 - position, scientific degree, academic rank – font normal;
 - institution – in brackets, italic.
- Title of a paper: bold, capital letters, without any hyphenation, alignment centred.
- Text: alignment justified, without hyphenation.
- References: at the end of the text in the order of reference, alignment in width, enumerated according to specified requirements.
