Dear Colleagues,

CEPOL – The European Union Agency for Law Enforcement Training and **Mykolas Romeris University** are jointly organising the next European Police Research and Science Conference in early December 2021.

The conference will take place from Wednesday 1 December, starting at 09:30hrs and ending on Friday 3 December after lunch at 13:30, at the premises of the Mykolas Romeris University in Vilnius, Lithuania. The date of arrival for participants is Tuesday 30 November.

The target groups for participating in this event are:

- Heads, senior staff, educators and trainers of law enforcement training institutions;
- Law enforcement officers in leading positions;
- · Law enforcement officials in charge of organisational development;
- Academic scholars and researchers;
- CEPOL Research and Science Correspondents (see GB 28/2008)

The overall **aim** is to provide the opportunity for exchanging information among professionals about innovations in the law enforcement area, research findings case studies and challenges for innovation processes, innovative educational ideas and concepts as well as for engaging in a professional and informed discussion around general issues in the area of police science, research and education in particular in Europe.

Registration process

The registration procedure is separate for delegated participants from CEPOL Member States and for participants from Associated and Candidate Countries, JHA agencies and other organisations and countries:

1. CEPOL Member States

We are pleased to offer an initially granted contingent of **four (4) seats for each Member State. Hotel accommodation has been reserved and** expenses will be covered in accordance with the stipulations in MB decision 14/2017/MB.

Contact Points can apply for even more participants, as there will be a re-distribution of unclaimed positions after the notification deadline.

2. Associated and Candidate countries, and also other countries/organisations

Participants from countries and organisations with whom CEPOL has a cooperation/working agreement may attend at their own cost. Here registration needs to be done via the link on the CEPOL website: https://www.cepol.europa.eu/science-research/conferences) Registration will open from 1 October 2021.

For the flight bookings **Candidate Countries** are requested to also send a **Registration/Travel request** to <u>conference2021@cepol.europa.eu</u> as flight costs for Candidate Country delegates will be covered by CEPOL.

Costs for participation **at own expense** (self-payers) are estimated at: Hotel accommodation incl. breakfast (€60-80) per day); the cost of lunches and coffee breaks will be covered by CEPOL; dinners between €20-30, taxi costs from and to the airport approx. €20 in total (public transport from airport to city centre with bus 3G is 0,6 EUR 30 minutes' drive, 0,8 EUR 60 minutes' drive, it takes approximately 25 minutes to go from the airport to the city centre).
