THE OBJECTIVE OF THE CONFERENCE

The essential aim of the conference is to create a platform for dialogue and exchange of scientific knowledge between legal science and legal practice, public administration authorities in the field of protection of material cultural heritage in the conditions of the Slovak Republic. Furthermore, it is also the presentation of the results of scientific research activities in several areas of legal science, the creation of space for the establishment and deepening of cooperation between domestic and foreign universities together with the environment of legal practice and the mutual exchange of experience and knowledge. The conference is also expected to be beneficial in terms of enhancing communication between individual faculties and the possibility of publishing scientific outputs in peer-reviewed scientific proceedings. PAPERS INSTRUCTIONS

- maximum 12 pages
- Submit the paper in MS Word (.doc, .docx, .rtf) format, not .pdf
- Times New Roman font throughout the text of the paper
- line spacing throughout the text of the paper 1,5 (except footnotes)
- line spacing ('line spacing options'): before, after: - 0b
- file margins 2,5 cm (all pages)
- do not use pagination in the paper
- use a tab (1,25 cm) in the text
- title in SJ (14, bold, capital letters, centred from the left)
- title in AJ (14, bold, capital letters, centred from left)
- name and surname of the author(s), without titles (12, bold, centred from left)
- 1. footnote - short CV about the author(s) of the paper (titles, first name, last name, place of work - university, department, classification, possibly other) (10, line 1)
- paper structure - abstract in Slovak/ Czech key words in Slovak/ Czech, abstract in EN, key words in EN, introduction, core, conclusion, list of bibliographic references (titles and layout by author)
- abstract in Slovak/ Czech (10, italics, align text per page) - max. 6 lines
- key words in Slovak/ Czech (10, justified text per page) - max. 5 lines words
- abstract in English (10, italics, align text per page) - max. 6 lines
- key words in English (10, align text per page) - max. 5 kl. words
- headings in the text (12, bold, align text to page), text of the paper (12, align text to page, use tab (1.25 cm) in the text),
- quotations and explanatory notes should be given in a footnote
- citations and explanatory notes should be given in a footnote (10, line 1, align text to page)
- list of bibliographical references (12, bold, in alphabetical order - cf. above, without numbering, align text to page)
- footnotes to be inserted automatically via 'References - Insert footnote'

Submissions will not be edited; if the template is not followed, submissions will be returned to authors for revision.
