









ANNOUNCEMENT

Dnipropetrovsk State University of Internal Affairs, in cooperation with the National Academy of Public Prosecutor of Ukraine and the Department for Combating Narcotic Crimes of the National Police of Ukraine, will hold the International Scientific and Practical Conference "Counteracting Crimes Against Drug Crimes in Ukraine and the World: Problems and Ways to Solve them", which will be held in the city of Dnipro (Ukraine) June 21 - 22, 2018.

Representatives of international organizations, institutions of higher education, research institutions, law enforcement agencies, non-state institutions of Ukraine and foreign states will be invited to participate in the conference, who will discuss issues concerning the construction of international cooperation on combating illicit trafficking in narcotic drugs, psychotropic substances, their analogues and precursors at the interdisciplinary level.

The goal of the Conference

The purpose of the conference is to unite efforts of law enforcement officers of Ukraine and foreign states, European and world experts, other persons interested in solving the problems of counteracting drug crimes, studying experience in this sphere, global, regional and local perspectives.

The priority areas of the conference are:

 Theoretical-legal and conceptual approaches to counteracting drug crimes in the world;

- International experience of the activities of law enforcement agencies of foreign countries in counteracting drug crimes;
- Strategy in counteracting drug crimes in Ukraine;
- The activities of law enforcement agencies of Ukraine in the area of counteracting drug crimes and international cooperation in this direction;
- Counteracting crimes related to the illegal trafficking of narcotic drugs, psychotropic substances, their analogues and precursors by criminal law;
- Detection, prevention and investigation of crimes related to the illegal trafficking of narcotic drugs, psychotropic substances, their analogues and precursors;
- Control over the legal circulation of narcotic drugs in Ukraine and in the world

The languages of the conference are Ukrainian, English and Russian.

At the beginning of the conference will be published a collection of articles in the special issue of the Scientific Herald of the Dnepropetrovsk State University of Internal Affairs.

REQUIREMENTS FOR PREPARATION AND SUBMISSION OF ARTICLES

According to the scientific content, the articles must comply with the requirements approved by the decision of the Presidium of the Higher Attestation Commission of Ukraine dated 15.01.2003 No. 7-05 / 1 "On increasing the requirements for professional editions included in the lists of the Higher Attestation Commission of Ukraine", namely: statement of the problem; analysis of publications in which the solution to this problem was initiated; purpose of the article; presenting main material; conclusions. The names of these structural elements are highlighted in bold text in the text of the article.

The publication manuscript must be typed in a MicrosoftWord text editor and printed in 2 copies. on one side of the white standard A4 sheet and meet the following requirements: fields - 2 cm, font - TimesNewRoman, size (font) - 14, line spacing - 1,5; Pages are not numbered; before the title of the article, the case in separate lines - the surname and initials of the author, the scientific degree and academic rank (in their absence, the position is indicated, for example, "teacher", "applicant", "graduate student", etc.), place of work; further in the middle is the title of the article in capital letters, after the name - UDC number, then - abstract in Ukrainian (2-3 sentences and 4-5 key words), the text of the publication, after the text - a list of sources used (alphabetically or in order of use) without repetitions, while complying with the applicable requirements for bibliographic registration. The text itself also indicates references to the sources used (in square brackets, the reference number on the list at the end of the text, and the page numbers).

After the list of sources - abstract in English (name of the author and title, text to 2000-2500 characters with spaces, 4-5 keywords).

At the end of the manuscript - the signature of the author and the date.

The volume of the manuscript of the article (without taking into account annotations and the list of sources used) - 8-12 pages. The manuscript of the article is attached to:

- 1). Review, stamped by the authorities (for authors who have degrees or academic titles, availability of review is not required);
- 2). Information about the author: name, surname, patronymic (in full), title, place of employment, academic degree and academic title, business address, contact numbers, e-mail:
- 3). Electronic carriers of the manuscript and photo of the author (in jpeg format) a CD-ROM (CD-R).

Materials that do not meet the specified requirements are not accepted. Manuscripts and electronic media do not come back. The editorial staff reserves the right, without the consent of the author, to make changes, additions, or rename the manuscript in the text of the manuscript. In case of receipt of materials from other institutions necessarily carried out their additional review on the appropriate departments of the university. For the reliability of published facts and results of their own research responsibility is borne by their authors. When quoting the collection materials, reference to the collection is compulsory. Not accepted for publication of articles that have already been published or submitted for publication in other editions.
