# VIII INTERNATIONAL STUDENT SUMMIT «*Human rights and global security*»

**November 03-04, 2022**  
(*in face-to-face / online format*)

The co-organizers of the event are the Dnipropetrovsk State University of Internal Affairs and the All-Ukrainian public organization «Association of Ukrainian Lawyers».

*The purpose of the VIII International Student Summit is to unite the efforts of scientists around the understanding of the values of human rights and freedoms, which are ensured and protected on the basis of the principles of equality and non-discrimination, the development of mechanisms for the protection of human rights and freedoms in the conditions of national and global security challenges, the development of directions for the state politics of Ukraine in the post-war period, continuing the systematic formation of Ukrainian-oriented values in the younger generation, increasing the positive image of the legal profession in Ukraine, improving the knowledge and skills of higher education graduates on current issues of modern state-building, law-making and law-enforcement processes, stimulating the comprehensive self-improvement of student youth.*

Applicants from higher education institutions of Ukraine and foreign countries are invited to participate in the Summit. **One team** (no more than 3 people) can be represented at the Summit from an educational institution.

The *project* presented at the Summit must be *exploratory and innovative in nature*, have *scientific and practical* significance, contain provisions for *improving current legislation taking into account positive foreign experience*, and be aimed at *solving the following problems in the field of jurisprudence, political science, public administration*, etc.

| <b>Block 1.</b> | Legal regime of martial law in Ukraine. Public administration under the legal regime of martial law. The Armed Forces and other military formations of Ukraine, law enforcement agencies in ensuring the defense of Ukraine, protecting the safety of the population and the interests of the state in conditions of martial law. Legal basis for the participation of foreigners and stateless persons in hostilities as part of the defense forces of Ukraine..   |
| <b>Block 2.</b> | Ways of solving the main systemic problems in the sphere of provision, implementation and protection of human rights and freedoms in the conditions of armed aggression. Ways of introducing a systemic approach to ensuring human rights and freedoms, coordination of actions of state authorities, local self-government bodies, civil society institutions, business entities, elimination of systemic deficiencies that underlie violations identified by the European Court of Human Rights. Convention mechanism of international protection of human rights in the UN system: institutional and procedural aspects. |
| <b>Block 3.</b> | Rights, freedoms and legitimate interests of refugees and internally displaced persons in Ukraine and other countries of the world: mechanism of protection. Guarantees of ensuring the rights of servicemen and their family members in a special period. Legal status of persons missing under special circumstances. Legal status of prisoners of war. International standards of treatment of prisoners of war and their implementation in Ukraine. Legal aspects of volunteering. Peculiarities of the legal status of a volunteer.  |

<b>Block 4.</b>	Legal problems of the formation and implementation of the internal and external policy of the state in the conditions of martial law. The rule of law as a model of the organization of power in modern society. Local self-government during martial law. International and domestic mechanisms for ensuring the rule of law in the conditions of modern challenges and threats. Justice of the transitional period and the issue of post-war institutional judicial reform.
<b>Block 5.</b>	National security as a fundamental component of the interests of human, society and the state in the conditions of martial law. Information and hybrid wars in modern globalization conditions. Ensuring information sovereignty and determining approaches to the protection and development of the national information space.
<b>Block 6.</b>	Criminal-legal qualification of war crimes and crimes against humanity, the issue of torture and inhumane treatment in the conditions of war in the light of modern international law. Collaborative activity in national legislation and international acts: concepts, forms, legal responsibility, qualification issues.
<b>Block 7.</b>	International and national environmental security in the conditions of large-scale armed aggression of the Russian Federation against Ukraine. Peculiarities of guarantees of environmental rights and freedoms of human and citizen. The practice of national courts and the European Court of Human Rights in the field of protection of citizens' environmental rights. International legal cooperation in the field of environmental issues.
<b>Block 8.</b>	Modernization of the international peacebuilding network in the conditions of global and regional security challenges. The role of international organizations and international associations in building peace and peaceful settlement of military conflicts. The role of the European Union in building peace on the example of Ukraine. The impact of the European integration process on the mechanism of ensuring human rights and freedoms in Ukraine in the post-war period. Evaluation of the effectiveness of human rights guarantees for refugee status in the conditions of international and national conflicts. International legal responsibility in the 21st century.
<b>Block 9.</b>	Gender policy in judicial and law enforcement spheres. Integration of the gender component in various spheres of public life and public administration (education, law, ecology, health care, regional policy, energy, public finance management, employment, and others): problems and prospects. Combating gender-based violence, domestic violence, human trafficking and slavery. The impact of the ratification of the Istanbul Convention on the mechanism of ensuring gender equality in the conditions of martial law in Ukraine.

Summit participants send their projects to the organizing committee at the email address [Summit\\_dduvs@ukr.net](mailto:Summit_dduvs@ukr.net). The project is sent in Microsoft Word format (see requirements), which will be published in the collection of the annual scientific event on the topic «*Actual problems of state formation, law-making and law enforcement*».

### Requirements for the design of the project

In Microsoft Word format: *title page, table of contents, list of abbreviations* (if necessary), *main text* (up to 20 pages), *list of used sources, appendices* (if available); Times New Roman font, 14 point, style – normal, spacing 1.5; margins: left, bottom and top – 20 mm, right – 10 mm; paragraph – 12.5 mm, width alignment. References in the text are indicated in square brackets, for example: [4, p. 3].

Presentation by project teams will take place in video conference mode in the Zoom online system. A conference ID and password will be sent to participants before the event begins.

In advance, each team ***must register electronically***. The registration procedure involves submitting an application to the organizers of the established sample (see sample application). Within 2-3 days from the moment of sending the application, the participants will receive a notification about its receipt.

Applications are sent to the address: ***Summit\_dduvs@ukr.net*** with a note in the subject of the letter «**To the Summit. The name of the higher education institution of the team**».

The deadline for submitting an application for participation in the Summit is **October 28, 2022**; of the project for further publication - **November 18, 2022**.

The projects of the participants will be evaluated by an **International jury** consisting of recognized **national and international experts** in the field of law and other related sciences, representatives of authorities, politicians, etc.

According to the results of the **VIII International Student Summit**, the best teams, as determined by the International Jury, will be awarded **Diplomas of the 1st, 2nd and 3rd degrees, Diplomas in individual nominations**, special awards from the organizers, and each team will receive memorable and valuable gifts from the organizers and partners of the event. Diplomas and valuable gifts will be sent to the teams at their locations after the results are determined.
